## CONTRACT AGREEMENT

**THIS AGREEMENT** made the 23<sup>rd</sup> day of March, 2021 between **MINES AND GEOSCIENCES BUREAU, REGIONAL OFFICE NO. 1** represented by **Regional Director CARLOS A. TAYAG** hereinafter called "**First Party**" and **RANCHEZ EXPRESS TRAVEL & TOURS AGENCY** represented by **ENGR. ROBERT L. RANCHEZ, OWNER/PROPRIETOR** of No. 220 National Highway, Carlatan, San Fernando City, La Union hereinafter called "**Second Party**" of the other part:

**WHEREAS**, the First Party invited Bids for Provision of Motor Vehicle Rental for the Use of MGB-Region 1 Technical Personnel in the Conduct of Field Works, 1 Lot and has accepted a Bid by the Supplier for the Provision of Motor Vehicle Rental in the sum of **Five Hundred Eighty-Five Thousand Eight Hundred Eighty Pesos only (Php585,880.00)** hereinafter called "**the Contract Price**".

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the First Party to the Second Party as hereinafter mentioned, the Second Party hereby covenants with the First Party to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The First Party hereby covenants to pay the Second Party in consideration of the provision of the services and the remedying of defects therein, the Contract Price under the provisions of the contract at the time and in the manner prescribed by the contract.
